Different libraries choose variant authority-record formats for their Chinese authority data.</p> <p>(b) Members agreed that a union database to be established to cater the special needs the Hong Kong bilingual society, as well as to reflect the unique characteristics of the local authors &amp; organizational names.</p> <p>(c) Member libraries were invited to take part in this Project based on voluntary participation.</p> <p>(d) Members hoped that funding could be sought from UGC.</p> <p>(e) Members submitted a small sample (500 records) to LU for initial testing.</p> <p>(f) Convenor pointed out that III does NOT support double 1XXs in authority records.</p> <p>(g) CUHK expressed their initiative to host HKCAN Database.</p>

5-1999	<p>(a) Convenor visited NCL &amp; obtained part of their authority software for testing purpose.</p>																								
20-8-1999	<p><b>3<sup>rd</sup> HKCAN Meeting:</b></p> <p>(a) Convenor introduced the NCL's Authority Software to members for consideration.</p> <p>(b) Convenor contacted software vendor, (Transmission Information System Company), to discuss the possibility of developing an authority software, with format modeled after the NCL version.</p> <p>(c) Members decided that 1<sup>st</sup> 1xx should be in original Chinese script, &amp; 2<sup>nd</sup> 1xx should display LC headings.</p> <p>(d) Members agreed to seek III's support on our double-1xxs authority model.</p> <p>(e) Members agreed that CUHK to be responsible for hosting the HKCAN Database.</p>																								

30-8-1999	(a) Ms. Joan M. Aliprand (Senior Analyst of RLG & Secretary of Unicode Consortium) came to LU to discuss our authority model, & suggested that local tag, "19X" be employed for storing the LC form.
28-9-1999	(a) 1 <sup>st</sup> request to support tag 19x in authority records was declined by III's Help Desk.
15-10-1999	<b>4<sup>th</sup> HKCAN Meeting:</b> (a) Convenor also mentioned the possibilities of using tag 7xx for our authority model. (b) Finally, most members agreed that tag 19x should be employed.
22-10-1999	(a) LU Librarian contacted other UGC librarians to explore different alternatives to fund the Project. However, no consensus was made.
10-1999	(a) 19x Model was presented directly to Aaron Blazer & III's President, Jerry Klein during their visit to Hong Kong. (b) Formal request was submitted to Aaron Blazer by Convenor & CUHK.
4-11-1999	(a) Aaron replied they faced difficulties in supporting tag 19x, & counter-proposed that 880 fields to be used.
4-11-1999	(a) The Project was presented by the Convenor at the "Conference on Chinese Libraries in the 21 <sup>st</sup> Century" held at CUHK.
6-11-1999	(a) Memorandum of Agreement on the development of the HKCAN Software was signed by the Heads of CUHK, LU & NCL.
11-11-1999	(a) Workgroup declined to accept tag 880, and further pursued III to support tag 19x.
16-11-1999	(a) III finally agreed to support tag 19x, & they would identify a software solution to meet our goals. However, no specific timeframe was given.
12-2000	(a) LU & CUHK Librarians agreed with the following funding proposal: →CUHK will pay for the hardware & Backfile cost. →LU will cover the software cost.
28-12-1999	(a) Contract was signed between LU & TIS for developing the HKCAN Software.
2-2000	(a) All member libraries FTP their existing authority records to LU. (b) A total (60,000 records) were collected.
9-3-2000	(a) Convenor presented the Model at CEAL's Annual Conference in San Diego, & received positive & overwhelming responses & feedback.
3-2000	(a) TIS successfully completed the remote installation of the Software at CUHK site.
15-3-2000	(a) TIS completed the following modules of the Software: i. "Basic Searching" ii. "Duplication Checking" iii. "Adding New Records" & iv. "Record Updating & Maintenance" (b) Member libraries proceeded with their testing of the Initial Phase accordingly.
10-4-2000	<b>5<sup>th</sup> HKCAN Meeting:</b> (a) LU collected feedback from members after the Software's initial testing. (b) Committee discussed various types of membership, & their obligations & responsibilities. (c) Future planning, on-going maintenance & funding proposal for Software after 2001, were also tabled at the meeting.

	<p>(d) Planning for the 2<sup>nd</sup> Phase will take place in early 2001. HKCAN Database should be linked directly via Z39.50 to individual libraries' catalogues as a subsystem.</p> <p>(e) Convenor followed up with III regarding the indexing/linking/display of double 1xxs in authority records.</p> <p>(f) Members agreed that on behalf of the Workgroup, LU would write to Dr. Barbara Tillett of LC, to seek for LC's support on our Model.</p>
17/18-4-2000	(a) TIS conducted a 2-day "HKCAN Software Testpac Workshop" – to discuss with member libraries regarding the technical problems & expected enhancements associated with the Software.
5-2000	(a) III's reply -- they agreed to support the 19x Model in Autumn 2000. However, they explained that concurrent retrieval of bilingual materials cannot be achieved at the moment.
24-5-2000	(a) Reply received from Dr. Tillett – stated that LC would NOT support tag 19x.
6-2000	(a) CUHK acquired authority data from NLC.
6-2000	(a) "Export MARC" Function, & all reported software problems are expected to be resolved by TIS.
9-6-2000	<p><b>6<sup>th</sup> HKCAN Meeting:</b></p> <p>(a) To discuss the possibilities of using 7xx, and its potential impacts on the Project.</p>
8-2000	(a) According to LC's arrangement, name & series authority records will be converted by OCLC & redistributed in August 2000.
10 to 12-2000	<p>(a) CUHK will complete Pinyin Conversion Project, &amp; will resubmit all updated records (in batch) to LU accordingly.</p> <p>(b) Meanwhile, LU will begin removing duplicates.</p>

Based on the study's outcome, OCLC will make recommendation on the feasibility and desirability of working together to make these 3 files more useful on a global scale.</li> <li>● Host Institution also granted Mr. Abraham YU access to the HKCAN database for performing his evaluation study.</li> <li>● Meanwhile, HKCAN Workgroup would investigate whether it would bring benefits to the project if HKCAN members were to become members of NACO.</li> </ul>
